ACKNOWLEDGMENT OF RISKS: The undersigned recognizes and understands there are risks associated with entry into and participation in the Show including, but not limited to, bodily injury or death, and damage to property or privacy rights. The undersigned further acknowledges that they will be liable for all damages to persons, livestock, or property that is caused by them or any persons (including, but not limited to, minors) under their care and control, and that arise out of, or are related to, the undersigned's entry into and participation in the Show.

WARNING

UNDER CHAPTER 87, TEXAS CIVIL PRACTICE AND REMEDIES CODE, A LIVESTOCK SHOW SPONSOR IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN A LIVESTOCK SHOW RESULTING FROM THE INHERENT RISKS OF LIVESTOCK SHOW ACTIVITIES.

RELEASE FROM LIABILITY: The undersigned hereby RELEASES, ACQUITS AND FOREVER DISCHARGES AND AGREES TO DEFEND, INDEMNIFY AND HOLD HARMLESS the **BLUEBONNET BRAHMAN BREEDERS ASSOCIATION** ("BBBA), their present and former members, directors, officers, employees, agents, and representatives and the respective heirs, administrators, executors, successors and assigns and any other person, firm or corporation (collectively the "BBBA Parties") from any and all claims, causes of action, suits and/or demands for personal injury, death or property damage, accrued or to accrue in the future, known or unknown, (collectively, "Claims") relating to or arising out of any negligent, grossly negligent and/or intentional or unintentional acts on the part of the undersigned in connection with entry into and participation in the Show. Without limiting the foregoing, the undersigned agree that the BBBA Parties shall not be liable to them, their family, heirs, administrators, executors or assigns for Claims arising from or related to the undersigned 's entry into and participation in the Show. The undersigned understands that this Agreement shall be binding on his/her heirs, executors, successors and assigns, that this Agreement will be governed by the laws of Texas, If any part of this Agreement is determined to be invalid or unenforceable, it does not the affect the validity of the remainder of this Agreement. The undersigned agrees to the terms and conditions above and acknowledges receipt of this Agreement.
